From the Presiding Member and Chief Executive

Green Industries SA (GISA) is building on South Australia's achievements in waste management and resource recovery to develop the circular economy.

Our vision is to drive the world's most successful circular economy, using a zero waste model to innovate, adapt and lead. GISA's key strategic priorities are:

- Lead the circular economy
- Support innovative resource recovery
- Reform household and food waste
- Reform packaging and single-use items
- Build disaster waste resilience

In 2019-20, we worked with 27 businesses to implement circular economy projects related to: resource efficiencies, improvements in waste avoidance and management, and sustainable business practices. Through this work, more than \$2.26 million in potential direct savings were identified for these businesses.

In 2019-20, GISA implemented the state government's Waste and Resource Recovery Modernisation and Council Transition Package (the Package), which provides funding to industry and local government to transition and modernise waste management services and resource recovery infrastructure. Through implementation of the package and other funding and incentive programs, GISA approved more than \$7 million in grants to businesses, industry and local government to improve efficiencies, divert materials from landfill and improve the quality of recovered materials.

In 2019-20, we developed two significant strategy documents and released them for public consultation:

- Draft *South Australia's Waste Strategy 2020-25* – the next statutory waste strategy that outlines targets, objectives and actions for diversion of waste from landfill in South Australia over the next five years to support a transition to a circular economy
- Draft *Valuing our food waste: South Australia's strategy to reduce and divert household and business food waste* – actions to reduce and divert food waste from landfill, recognising the significant circular economy benefits that can be achieved

Following overwhelming feedback and support on the *Turning the tide on single-use plastic products* discussion paper that was developed by GISA and released in 2018-19, the Minister for Environment and Water, the Hon David Speirs MP, announced South Australia's approach to single-use plastic products in July 2019.

GISA is leading this work and in 2019-20 worked with a taskforce of key stakeholders and the Minister to develop legislation to restrict and prohibit certain single-use and other plastic products. Draft legislation was released for consultation from December 2019 to February 2020, and was introduced to South Australia's Parliament on 30 April 2020.

We also engaged the Boomerang Alliance to implement South Australia's plastic-free precincts program (Plastic-Free SA). In 2019-20, 60 businesses signed up as members of plastic-free precincts and seven businesses were awarded 'champion' status under the program.

In January 2020, our role as Functional Lead for disaster waste management under the State Emergency Management Plan was activated to lead the clean-up of bushfire-affected materials and debris, including hazardous materials, from more than 500 South Australian properties on Kangaroo Island, the Adelaide Hills, Yorke Peninsula and Keilira.

Other projects and programs delivered by GISA in accordance with our Business Plan in 2019-20 include:

- Delivering the Global Leadership Program on the Circular Economy to 24 international and interstate participants from industry and government in February 2020
- Continuing development and delivery of the *Which Bin* recycling education campaign and engaging with local government waste educators state-wide
- Monitoring progress against landfill diversion targets in *South Australia's Waste Strategy 2015-20* and development of the state's Recycling Activity Survey for 2018-19
- Contributing to national policy initiatives, including the Action Plan supporting the National Waste Policy and response strategies to support the national ban on the export of certain waste materials
- Administering subsidies to regional South Australian councils to assist with the transport of recyclable materials to processing facilities
- Disposing household chemicals and paint through the four metropolitan Adelaide facilities established by GISA and local government in 2018-19.

We look forward to continuing these activities and driving the circular economy in South Australia in 2020-21. Priorities include finalising *South Australia's Waste Strategy 2020-25* and *Valuing Our Food Waste*, passage and implementation of the single-use plastics legislation, and further investment in the state's resource recovery sector.

The agency is subject to the direction of the Minister for Environment and Water, except in relation to making a recommendation or report to the Minister.

GISA is led by a Chief Executive appointed under section 8 of the *Green Industries SA Act 2004*, and three Executive-level positions – Deputy Chief Executive; Director, Business; and Director, Strategy and Policy.

Changes to the agency

During 2019-20, GISA appointed a Deputy Chief Executive to support succession planning for the agency. There were no major changes to GISA's structure as a result of this appointment, or as a result of any internal reviews or machinery of government changes.

In accordance with the *Green Industries SA Act 2004*, GISA works closely with and makes use of information from the EPA in relation to waste management and resource recovery. GISA also coordinates and liaises with the EPA in the development and implementation of waste strategies under the Act.

In the course of its projects and programs, and business functions, GISA also works with other state government agencies, including the Department of Primary Industries and Regions, Department of Planning, Transport and Infrastructure (DPTI), Department for Trade and Investment (DTI), Department of Treasury and Finance (DTF), Department of the Premier and Cabinet (DPC), Department for Energy and Mining (DEM), Auditor-General’s Department and SAFECOM.

Corporate performance summary

There has been no loss of productivity in response to working from home measures introduced in response to COVID-19 isolation requirements. In the week of 16 March 2020, GISA staff transitioned to working from home. Within three days, all 22 staff had transitioned to working from home, with the agency providing supporting ICT and ergonomic equipment and introduced measures to ensure staff mental wellbeing and safety. A staged transition for a return to GISA's office commenced in June 2020 in accordance with the advice of health authorities.

GISA achieved its allocated savings target of \$0.49 million for 2019-20.

Financial performance

Financial performance at a glance

The following is a brief summary of the overall financial position of the agency. The information is unaudited. Full audited financial statements for 2019-20 are attached to this report (**Appendix A**).

GISA is funded from the solid waste levy via the Green Industry Fund as per section 17(3)(a) of the *Green Industries SA Act 2004*.

In 2019-20, the Green Industry Fund received \$49.789 million in revenue, of which \$37.036 million was received in solid waste levy transfers from the EPA and \$12.02 million was received from DTF for bushfire clean-up. The agency's total expenditure in 2019-20 was \$70.566 million, including \$40.204 million in intra-government transfers for climate change initiatives (see other financial information below).

The balance of the Green Industry Fund at 30 June 2020 was \$114.122 million.

Other financial information

In 2019-20, \$40.204 million from the Green Industry Fund was transferred to other state government agencies for climate change initiatives, as approved by the Minister for Environment and Water independent of the GISA Board, pursuant to section 17(5)(b)(i) of the *Green Industries SA Act 2004*. The funding was allocated towards:

- Home Storage Subsidy Scheme and Grid Scale Storage Fund – DEM (\$27.205 million)
- Grid Scale Storage Fund – DEM (\$2.25 million)
- Low Carbon Economy Unit – DEM (\$1.391 million)
- Metropolitan Beach Management – DEW (\$3.9 million)
- Preparing for Climate Change – DEW (\$2.256 million)
- Carbon Neutral Adelaide Partnership Framework – DEW (\$1.042 million)
- Regional Coastal Remediation – DEW (\$1 million)
- Coastal Protection – research and development for sand retention, seagrass meadow restoration – DEW (\$0.66 million)
- Adelaide Living Beaches – DEW (\$0.5 million)

Risk management

Risk and audit at a glance

The GISA Board has established the Governance Committee under section 12 of the GISA Act to provide advice to the agency and Board regarding the management of corporate governance issues and risks.

The agency has robust corporate governance practices, including in relation to risk management, fraud and corruption control, financial management and legislative compliance. GISA's Risk Management Plan is subject to regular review by the GISA Executive team, the Governance Committee and the Board.

GISA and the EPA coordinate activities on a range of waste management and resource recovery matters. Key activities in 2019-20 included:

- Development and release for consultation of the draft *South Australia's Waste Strategy 2020-25* and draft Food Waste Strategy (*Valuing Our Food Waste*)
- Development and introduction to Parliament of the Single-use and Other Plastic Products (Waste Avoidance) Bill 2020
- Contribution to national and interstate policy matters including the Action Plan (2019) under the National Waste Policy (2018) and response strategies to support the national ban on the export of certain recyclable materials.
- Progression of regulatory reforms to South Australia's waste management and resource recovery sector.

Other matters discussed and coordinated between the agencies in 2019-20 include:

- Licensee compliance as part of grant funding due diligence
- Waste, resource recovery, landfill and solid waste levy data

- Waste management arrangements of charitable organisations
- Ministerial and Parliamentary business.

The coordination of activities between GISA and the EPA is undertaken at a number of levels, including regular meetings between Chief Executives and frequent discussions at director, manager and officer level.

South Australia's Waste Strategy 2015-2020 advocates for high levels of recycling and reuse through targets and actions to reduce waste to landfill, and requiring innovative policy and regulatory solutions. It has the following landfill diversion targets for each waste sector:

- 70 per cent of Municipal Solid Waste (MSW) by 2020
- 80 per cent of Commercial and Industrial (C&I) waste by 2020
- 90 per cent of Construction and Demolition (C&D) waste by 2020

GISA's programs throughout 2019-20 implemented the Waste Strategy through policy and strategy development; the provision of funding for improved resource recovery infrastructure; increased diversion from landfill; improved services for the community; resource efficiencies for businesses; commercialisation of new innovations and technologies; increasing recycling awareness; and management of disaster waste.

South Australia's Recycling Activity Survey Report for 2018-19 (prepared in 2019-20) shows the following progress against the Waste Strategy landfill diversion targets:

- 57 per cent for MSW
- 88.2 per cent for C&I waste
- 91.4 per cent for C&D waste

Existing waste strategy targets are being met in the C&I and C&D waste sectors. There are further step-wise improvements to be made in the MSW stream.

During 2019-20 GISA developed and released a draft waste strategy for South Australia covering the period 2020-25. The draft strategy has revised targets and priority actions for each waste sector.

Diverting food waste from landfill presents significant opportunities to increase recovery rates in the MSW and C&I sectors. In 2019-20, GISA developed and released a draft Food Waste Strategy, the state's first such comprehensive document, which has actions specific to increasing diversion of food waste from landfill.

1. About Green Industries SA

The reporting entity is referred to throughout these statements as Green Industries SA (GISA), and comprises the following:

- GISA – a statutory corporation with an appointed governing board established by the *Green Industries Act 2004*
- an administrative unit named the Office of Green Industries SA established under the *Public Sector Act 2009*
- the Green Industry Fund established under the *Green Industries SA Act 2004*.

The Chief Executive of the statutory corporation is subject to the control and direction of the Board in giving effect to its policies and decisions. The *Green Industries SA Act 2004* permits the statutory corporation to make use of the services of the administrative unit's employees and facilities.

1.1. Basis of preparation

The financial statements are general purpose financial statements prepared in compliance with:

- section 23 of the *Public Finance and Audit Act 1987*
- Treasurer's Instructions and Accounting Policy Statements issued by the Treasurer under the *Public Finance and Audit Act 1987*
- relevant Australian Accounting Standards.

For the 2019-20 financial statements GISA adopted *AASB 15 – Revenue from Contracts with Customers*, *AASB 16 – Leases* and *AASB 1058 – Income of Not-for-Profit Entities*. Further information is provided in note 9.

The financial statements have been prepared based on a 12 month period and presented in Australian currency. The historical cost convention is used unless a different measurement basis is specifically disclosed in the note associated with the item measured.

Income, expenses and assets are recognised net of the amount of GST except:

- when the GST incurred on a purchase of goods or services is not recoverable from the Australian Taxation Office, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item applicable

The Department for Environment and Water (DEW) prepares a Business Activity Statement on behalf of GISA under the grouping provisions of the GST legislation. Under these provisions, DEW is liable for the payments and entitled to the receipts associated with GST. Therefore, GISA's net GST receivable/payable is recorded in DEW's Statement of Financial Position. GST cash flows applicable to GISA are recorded in DEW's Statement of Cash Flows.

Assets and liabilities that are to be sold, consumed or realised as part of the normal operating cycle have been classified as current assets or current liabilities. All other assets and liabilities are classified as non-current.

Where asset and liability line items combine amounts expected to be realised within 12 months and more than 12 months, GISA has separately disclosed the amounts expected to be recovered or settled after more than 12 months.

1.2. Objectives and programs

Objectives

GISA promotes waste management practices that, as far as possible, eliminate waste or its consignment to landfill; and promotes innovation and business activity in the waste management, resource recovery and green industry sectors, recognising these areas present a valuable opportunity to contribute to the state's economic growth.

To achieve its objectives, GISA undertakes programs and projects according to *South Australia's Waste Strategy 2015-20* and its strategic plan and annual business plan which include:

- developing and implementing government policy objectives in waste management, resource recovery, green industry development and the circular economy
- encouraging innovation and economic growth through the circular economy and achieving environmental gains
- helping businesses to reduce their costs through more efficient use of materials, water and energy
- administering grants to local government and industry to drive innovation and best practice
- developing, administering and monitoring the State's Waste Strategy and first food waste strategy
- reporting against waste to landfill targets
- developing behaviour change programs for schools and householders to improve recycling and waste avoidance practices
- operating as functional lead in implementing the Government of South Australia's Disaster Waste Management Capability Plan.

Programs

To achieve its objectives, GISA undertakes its services through a single program, 'Waste reduction, resource recovery, circular economy and green industry development'.

1.3. Impact of COVID-19 pandemic on GISA

The COVID-19 pandemic has not had a material impact on the operations of GISA in the 2019-20 financial year.

- a The solid waste levy revenue collected by the Environment Protection Authority (EPA) was lower than the original budget predominately due to reduced metropolitan solid waste volume compared to the budget (\$2.379 million), timing of the cash transfer where the solid waste levies are budgeted on an accrual basis but the actual transfer of funds from the EPA to GISA is on a cash basis (\$3.356 million). The original budget was reduced by \$1.113 million during 2019-20.
- b Funding of \$12 million from the Department of Treasury and Finance (DTF) was not included in the original budget for clean-up, management and resource recovery from waste and debris, resulting from the 2019-20 bushfires in the Adelaide Hills, Kangaroo Island, Yorketown and Keilira.
- c Supplies and services is \$13.971 million greater than the original budget primarily due to approved spending from DTF (\$13.4 million in 2019-20) for bushfire clean-up, including clean-up-undertaken ahead of schedule and budgeted to be funded in 2020-21 (\$2 million) already completed.

1.5. Significant transactions with government related entities

Significant transactions with the SA Government are identifiable throughout this financial report. In addition:

- GISA had significant transactions with the EPA during the 2019-20 financial year. The net cost of services is the total cost of services less any revenue retained by public authorities involved in the provision of services but does not include items classified as revenues from and payments to the South Australian Government.

Presentation of the Statement of Comprehensive Income on an 'income and expense' basis allows information to be presented in such a way that eliminates potential confusion as to the source of funding for the department. 11. Measurement and risk

11.1. Long service leave liability - measurement

AASB 119 Employee Benefits specifies the calculation methodology for long service leave liability.

The actuarial assessment performed by DTF has provided a basis for the measurement of long service leave and is based on actuarial assumptions on expected future salary and wage levels, experience of employee departures and periods of service. These assumptions are based on employee data over SA Government entities.

AASB 119 Employee Benefits requires the use of the yield on long-term Commonwealth Government bonds as the discount rate in the measurement of the long service leave liability. The yield on long-term Commonwealth bonds has decreased from 2019 (1.25%) to 2020 (0.75%).

The actuarial assessment performed by DTF decreased the salary inflation rate from 2019 (4.0%) to 2020 (2.5%) for long service leave liability. The salary inflation rate for annual leave and skills, experience and retention leave liability decreased from 2019 (2.2%) to 2020 (2.0%). This change had an immaterial net financial effect in the current financial year.

The net financial effect of the changes to actuarial assumptions in the current financial year is a decrease in the long service liability of \$60 000. The impact on future periods is impracticable to estimate as the long service liability is calculated using a number of demographic and financial assumptions – including the long-term discount rate.

The unconditional portion of the long service leave provision is classified as current as GISA does not have an unconditional right to defer settlement of the liability for at least 12 months after reporting date. The unconditional portion of the long service leave relates to an unconditional legal entitlement to payment arising after 10 years of service.

Non-current assets are initially recorded at cost or at the value of any liabilities assumed, plus any incidental cost involved with the acquisition.

Where assets are acquired at no value, or minimal value, they are recorded at their fair value in the Statement of Financial Position. However, if the assets are acquired at no or nominal value as part of a restructuring of administrative arrangements then the assets are recognised at book value (that is, the amount recorded by the transferor public authority immediately prior to the restructure).

Revaluation

Property, plant and equipment are subsequently measured at fair value after allowing for accumulated depreciation.

The revaluation process is reviewed by the Chief Finance Officer and audit committee each year.

Non-current tangible assets are valued at fair value and revaluation of non-current assets or group of assets is only performed when its fair value at the time of acquisition is greater than \$1.5 million and estimated useful life is greater than three years.

As GISA does not hold assets that meet this criteria.

Fair value hierarchy

GISA classifies fair value measurement using the following fair value hierarchy that reflects the significance of the inputs used in making the measurements, based on the data and assumptions used in the most recent revaluation.

Level 1: traded in active markets and is based on unadjusted quoted prices in active markets for identical assets or liabilities that the entity can access at measurement date

Level 2: not traded in an active market and derived from inputs (inputs other than quoted prices included within level 1) that are observable for the asset, either directly or indirectly

Level 3: not traded in an active market and are derived from unobservable inputs.

GISA's policy is to recognise transfers into and out of fair value hierarchy levels as at the end of the reporting period.

During 2020 and 2019, GISA had no valuations categorised into level 1; there were no transfers of assets between level 1 and 2 fair value hierarchy levels and there were no changes in valuation technique.

11.3. Financial instruments

Financial risk management

Risk management is managed by GISA's corporate services section. GISA's risk management policies are in accordance with the *Risk Management Policy Statement* issued by the Premier and Treasurer and the principles established in the Australian Standard *Risk Management Principles and Guidelines*.

GISA's exposure to financial risk (liquidity risk, credit risk and market risk) is low due to the nature of the financial instruments held.

Liquidity risk

GISA is funded principally from waste levies received under the *Green Industries SA Act 2004* (refer to note 4.2). GISA's expenditure authority is approved by the Treasurer each year, based on budgeted revenues and expenditures outlined in an annual Business Plan.

Refer to note 7.1 for further information.

Credit risk

GISA has policies and procedures in place to ensure that transactions occur with customers with appropriate credit history.

No collateral is held as security and no credit enhancements relate to financial assets held by GISA.

Impairment of financial assets

GISA considers that its cash, cash equivalents and receivables have low credit risk based on the external credit ratings of the counterparties and therefore the expected credit loss is nil.

Market risk

GISA does not trade in foreign currency, enter into transactions for speculative purposes, nor for hedging. GISA does not undertake any hedging in relation to interest or foreign currency risk and manages its risk as per the Government's risk management strategy articulated in *TI 23 Management of Foreign Currency Exposures*.

GISA has no interest bearing liabilities as at the end of the reporting period. There is no exposure to foreign currency or other price risks.

There have been no significant changes in risk exposure since the last reporting period.

Categorisation of financial instruments

Details of the significant accounting policies and methods adopted including the criteria for recognition, the basis of measurement, and the basis on which income and expenses are recognised with respect to each class of financial asset, financial liability and equity instrument are disclosed in the respective financial asset / financial liability note.
