IMPACT OF THE SOLID WASTE LEVY INCREASE(S) ON RECYCLABLES PROCESSING AT THE NORTHERN ADELAIDE WASTE MANAGEMENT AUTHORITY

The Copper Coast Council transports its recyclable materials to the Northern Adelaide Waste Management Authority. Other Councils in the region that also do this include Port Pirie Regional Council, Barunga West Council, Adelaide Plains Council, Barossa Council, Yorke Peninsula Council and the Light Regional Council.

Your recent State Budget announcement of two increases in the Solid Waste Levy for 2019/2020 has resulted in an increase in contaminated waste from residents in the yellow top bins. This resulted in an increase in costs to the Northern Adelaide Waste Management Authority's to separate the contamination from recyclable material. These costs are now again passed on to local Councils. We are concerned that a Solid Waste Levy on recyclable waste will <u>again</u> have further cost increases for Councils.

Therefore, the Copper Coast Council considers that recycling waste should be exempt from any increases in the Solid Waste Levy. The recyclable materials transported to the Northern Adelaide Waste Management Authority are made into various products. I have attached a sheet showing the products that are made from the recyclable materials.

The Northern Adelaide Waste Management Authority has advised that effective from 1st July 2019 their recyclables processing gate fee would increase by \$3.50 per tonne. Should the second Solid Waste Levy increase from the 1st January 2020 proceed, this may increase again.

Therefore, we request that recycling waste be exempt from any increase from the Solid Waste Levy.

COPPER COAST COUNCIL – STATE GOVERNMENT WASTE LEVY INCREASE

The Copper Coast Council has a population of over \$15,000 and encompasses the towns of Kadina, Wallaroo and Moonta. The Council wishes to register its strong objection to the 40% increase in the State Government Waste Levy. The Copper Coast Council has adopted its budget with an average rate increase of 3.2 %.

The waste levy increase will mean that the Copper Coast Council will pay an estimated \$520,170, an increase of \$130,418. \$520,170 represents a 3% rate increase. If the Copper Coast Council did not have to pay the waste levy, our rate increase would have been 0.2% for 2019/20. The waste levy increase was also proposed when consultation had already been undertaken with the community on our proposed budget for 2019/20.

It is also noted that a large percentage of the waste levy collected form Councils is used for the Environment Protection Authority and it is understood for coastal protection works for Adelaide beaches. It would be appreciated if you could advise the reasons for the 40% increase in the waste levy, where the waste levy collected is spent, with details of such expenditure and whether there is any intention to review the waste levy payable by Councils. The waste levy and increase has and will continue to have a deleterious effect on Council services and projects for the benefit of our communities.
