I refer to your application (receipt number 18086257) pursuant to the *Freedom of Information Act* 1991 (the FOI Act) on 24 July 2023 requesting access to:

A copy of all correspondence (including but not limited to hard copy or electronic briefings, minutes, reports, emails, letters, meeting agendas, diary entries, event attendance records and any other correspondence) between Green Industries SA and the Member for Port Adelaide (including the Port Adelaide Electorate Office and the Member's staff) relating to the River Murray Flood Response, River Murray Flood Clean-Up, or River Murray Flood Recovery between 23 May 2023 and 24 July 2023

Due to a determination not being provided within the statutory timeframe, you sought an internal review on 24 August 2023.

A total of three documents were identified within the scope of your application. These are listed in the enclosed schedule. The information contained in the documents has been considered under the provisions of the FOI Act and as Principal Officer I have determined to grant full access to all three documents. Thank you for the following email, in response to my email to the Electorate Office of Susan Close 23 May 2023 detailing issues with the River Murray Flood Response.

This email is acknowledged in light of my understanding when I recently visited the electorate office for an update, Cameron advised you were to call me to discuss the issues raised.

I now note your intention was to respond in email.

In relation to your denial of my meeting request with Susan to discuss the issues raised in my email, on the basis, of your belief, the matter has no direct bearing on the Susan's electorate role, you will note I am a constituent in her electorate, residing in Swan Street Semaphore.

As is stated in my email, my company, whose registered office is also Swan Street Semaphore, has been denied opportunities in relation to the River Murray Flood response due to the behaviours of Green Industries SA.

Hence this has a direct bearing on Susan's electorate role.

Susan also needs to be aware the issues I have raised have contributed to the recent budget going from surplus to deficit, with the Treasurer referencing budget pressure on the flood response as a factor.

As I advised in my email, my company previously effectively led the bushfire response on Kangaroo Island for Green Industries, the then Minister responsible, David Speirs is now the opposition leader.

It is to he I will now turn with the issues I have raised, that he, no doubt, will raise these issues in parliament.

I will also advise David of this response.
